

SIR data submission deadline on 31 October

The window to submit data for the 2018/19 **Staff Individualised Record collection** closes on 31 October. All providers funded through the Education and Skills Funding Agency are requested to submit data, which is aggregated and analysed to show the changing structure and composition of the FE and training workforce, then published and communicated to the sector. The data informs policies aimed at tackling recruitment issues.
