The annual publication of the Further Education Workforce Data for England (SIR Data) report is significant because it provides the quality data necessary for informed decision-making. This year's **report**, based on more than 90,000 individual staff records, reflects trends including a growth in the size of colleges and an increase in the proportion of individuals spending 30 or more hours per year on CPD.

The last of those trends offers further evidence of the dedication to professional development that we see from colleagues across the sector. The ETF offers a wide variety of high-quality CPD and in May we published our new corporate brochure, setting out our full offer. I encourage you to take a look and **find out more** about how we can support you as you focus on getting behind your learners.

One of the newer ways in which the ETF supports the profession is the work we are leading on **Centres for Excellence in Maths**. The programme aims to help increase the number of young people leaving compulsory education with the necessary maths skills up to GCSE and Functional Skills level. That work enjoyed a **visit to one of the 21 Centres** from Anne Milton MP, Minster of State for Skills and Apprenticeships, this month.

Another project focusing on maths, trialling mastery approaches to its teaching of post-16 learners, has also been in the spotlight and I encourage all those with an interest in the subject to **read and watch the blogs and videos** featuring some of the teachers and trainers who have been participating.

Staying with the themes of post-16 learners and new approaches, I conclude by highlighting a new resource for English teaching. Our phonics toolkit is available free from our **Excellence Gateway site** and I hope the profession will make extensive use of it.



ETF to train teachers for 'essential digital skills' qualification

Topics will include using different devices and protecting privacy online.

# ETF post-16 phonics toolkit available

A new toolkit designed to support the use of phonics in teaching 16-plus students is now available on the ETF website.

It introduces resources created specifically for adult learners, explains how to put post-16 phonics approaches into practice in different settings, and explores how to adjust pace and sequence. ### Further Education Workforce Data for England report published

The latest **Further Education and Workforce Data for England report**, based on the 2017–18 Staff Individualised Record returns, was published in May. It identifies trends including a growth in the size of colleges, an increase in the proportion of teachers spending 30 hours or more on CPD each year, and a surge in the number of apprentices being employed compared to the previous year.





# Pathways to FE relaunched as Talent to Teach in FE

The ETF programme that helps final-year undergraduate and graduate students launch teaching careers in the Further Education and Training sector has been relaunched with a new name and improved support for participants. **Talent to** 

**Teach in FE** – formerly known as Pathways to FE – arranges 40-hour placements at a range of providers including colleges, independent training providers and local authorities. Applications can be made now.

### Further twenty-one practitioners conferred Advanced Teacher Status

The members of the second cohort of individuals to gain Advanced Teacher Status (ATS) have been announced following the conclusion of their viva interviews.

Twenty-one teachers and trainers have gained ATS, bringing the total number of holders to 49. They work in Further Education across the length and breadth of the country and are drawn from colleges, schools, training providers, local authorities and prisons.
